Explain why the answer choice is correct or incorrect.

Correct or Incorrect	Incorrect	The passage doesn't mention trials or being transported to another place. It has nothing to do with anything that happened overseas.
	Incorrect	The passage is not connected to the idea of a trial. Also, an entire colony cannot have a trial by jury. That is only for individuals.
	Correct	New York was banned from passing laws and punished for not following the Quartering Act. To dissolve means to end, and a <u>representative house</u> is the same thing as a <u>legislative assembly</u> .
	Incorrect	The passage is about a legislative assembly and laws, not about the justice system.
